I understand that by allowing my student to participate in any activity at a public venue I am giving permission for my student to be photographed or videoed, and will not hold Hayden Canyon Charter responsible for such. I also understand that photos and/or videos may be taken by the school during club activities for use on the school website and/or social media, and give permission for those images to be used.

I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my student's further participation in the activity. I have read this agreement, fully understand its terms, and understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed.

And I, the minor's parent and/or legal guardian, understand the nature of Dance activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. If, in the judgment of the adult leader in charge, the student needs emergency medical treatment as a result of any injury or sickness while under the care or control of Hayden Canyon Charter, I do hereby request, authorize, and consent to such emergency treatment as may need to be given to my child by any physician, licensed health care practitioner, or any medical treatment facility/hospital, specifically including the use of an AED; and I do hereby agree to indemnify and save harmless the adult leader in charge of the activity, and those affiliated with Hayden Canyon Charter, from any claim by any person whatsoever on account of such care and treatment of my child. The students own medical insurance will be charged for any and all medical treatment.
