Liability Release

This is a liability of release by and between Hayden Canyon Charter School and _____ (Student's name).

I, _____ (Parent's name) understand that Hayden Canyon Charter School does not require the student named above to participate in this activity, but I have elected to allow participation in the Dance Club, despite the possible dangers and risks that may occur. I fully recognize that there are dangers and risks to which my student may be exposed by participating in this activity.

I therefore agree, in consideration of and return for the services, facilities, and other assistance provided to me by Hayden Canyon Charter School in this activity, that I agree to RELEASE Hayden Canyon Charter School (and its Board of Directors, officers, employees, and agents) from any and all liability, claims and actions that may arise from injury or harm to my student, from my student's death or from damage to my student's property in connection with their participation in this activity.

I understand that this RELEASE covers liability, claims and actions caused entirely or in part by any acts or failures to act of Hayden Canyon Charter School (or its Directors, officers, employees, or agents), including but not limited to negligence, mistake, or failure to supervise by Hayden Canyon Charter School.

I recognize that this RELEASE means I am giving up, among other things, rights to sue Hayden Canyon Charter, its Directors, officers, employees, and agents for injuries, damages, or losses my student may incur. I also understand that this Release binds my heirs, executors, administrators, and assigns, as well as myself.

SPECIAL HEALTH CARE INFORMATION (allergies, medications, treatments, etc.)

I acknowledge, agree, and represent that I understand the nature of Dance activities and that my student is qualified, in good health, and in proper physical condition to participate in such activity. I further acknowledge that the activity may have times where the club performs at a venue that may be open to the public and that Hayden Canyon Charter is not able to monitor any photos and/or videos that may be taken at such a venue. I understand that by allowing my student to participate in any activity at a public venue I am giving permission for my student to be photographed or videoed, and will not hold Hayden Canyon Charter responsible for such. I also understand that photos and/or videos may be taken by the school during club activities for use on the school website and/or social media, and give permission for those images to be used.

I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my student's further participation in the activity. I have read this agreement, fully understand its terms, and understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed.

And I, the minor's parent and/or legal guardian, understand the nature of Dance activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. If, in the judgment of the adult leader in charge, the student needs emergency medical treatment as a result of any injury or sickness while under the care or control of Hayden Canyon Charter, I do hereby request, authorize, and consent to such emergency treatment as may need to be given to my child by any physician, licensed health care practitioner, or any medical treatment facility/hospital, specifically including the use of an AED; and I do hereby agree to indemnify and save harmless the adult leader in charge of the activity, and those affiliated with Hayden Canyon Charter, from any claim by any person whatsoever on account of such care and treatment of my child. The student's own medical insurance will be charged for any and all medical treatment.
